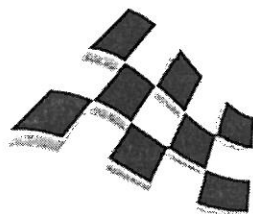
BESLUT

Patent- och registreringsverket (PRV) beslutar med stöd av 56 § 2 stycket varumärkeslagen (1960:644) att den under ovanstående nummer angivna internationella registreringen inte ska gälla i Sverige.

ÄRENDET

Ärendet avser giltighet i Sverige av den internationella varumärkesregistreringen RAJD LOTOS BALTIC CUP, se nedan, registrerad för polishing preparations for vehicles; car shampoo; liquids for cleaning all types of engines and car windows, upholstery cleaning fluids, wheel rim cleaners; windscreen washer fluids; rust removing preparations, klass 3, crude oil (raw or refined); fuel gas; crude oil products derived from the refining of crude; industrial oil, process oil, lubricants, fuels and grease included in this class, lubricating oils, diesel oil, fuel oil, base oil, gear oil, hydraulic oil, hydraulic gear oil; compressor, turbine, machine and shipping oils; oils for graphic paints, and for preservation of masonry, leather and fabrics; oils for releasing form work, moistening oils; mineral, semi-synthetic and synthetic oils for petrol and internal combustion engines; oils for agricultural and road equipment, and small auxiliary equipment; oils for metalworking and lubricating guides, petrolatum oil; heat treatment oils for use in metal working; oils for use in honing and lapping processes in metalworking and for machining; oils and greases for lubricating machinery in the food industry; multipurpose synthetic greases; grease for use with cutting instruments; fuel gas, such as propane and butane; propane-butane liquid gas; petrol; light petrol and naphtha; hydrocarbon compositions for petrol production; fuels; biofuels; alcohol-based fuels; aviation and marine fuels; bunker fuel; slack wax; paraffin; wax; candles; wicks for lighting, wood spills for lighting, illuminants; rape oil for industrial purposes; sunflower oil for industrial purposes; soya oil for industrial purposes, klass 4, wholesale services for fuel, oil and automobile parts, and assistance in the running of shops at petrol stations for the

retail of groceries, industrial products, stationery, magazines, books, maps, road atlases, as well as other consumer goods; market research and public opinion polling; cost analysis, business consulting, distribution of advertising materials, auditing and consulting in business activities, market research; advertising, promotion and sale of goods; import and export services; secretarial services; book-keeping, accountancy; tax preparation; compilation and systemization of information into computer databases; the bringing together, for the benefit of others, of a variety of goods (excluding the transport thereof), enabling customers to conveniently view and purchase those goods, such services being provided by wholesale or retail shops, second-hand shops or outlets, in relation to mechanical vehicles, vehicle accessories and engines, and motorcycles; organization and administration of loyalty schemes for customers, purchase and transaction management, book-keeping and drawing up of statements of accounts; promoting credit and debit cards through consumer incentive programs; radio and television advertising, advertising via computer networks, press advertising, distribution of advertisements, business management and administration services, office functions; business intermediary services relating to the trade of solid, liquid and gas fuels, derivatives, oils, car accessories, chemical products and semi-processed chemical products; psychological testing for the selection of personnel; advertising, organization of advertising and promotion campaigns; sales promotion services for retail distribution channels, such as petrol stations, oil replacement centres, garages and automobile shops, klass 35, och organization and conducting of conferences, congresses, seminars, symposia and exhibitions; organization of promotional sports events, tournaments and sports competitions; translation; film production; motion picture and video production; lending libraries; organization of national and foreign bicycle, motorbike and car rallies and races, sporting events, games and competitions; services related to the continuing education of adults; teaching and training activities, klass 41.
