BESLUT

Patent- och registreringsverket (PRV) beslutar med stöd av 5 kap. 9 § varumärkeslagen (2010:1877) att den under ovanstående nummer angivna internationella registreringen delvis inte ska gälla i Sverige. Den internationella registreringen ska inte gälla för följande varor:

pipes; seed trays; non-metallic oil and grease cans (for machines); non-metallic duckboards; non-metallic window bolts; baskets for hand towels; winding drums, construction hinges (non metallic); trays and tubs for mortar; vegetable planting trays (mainly non metallic); containers made of plastic, particularly of acrylic and/or polystyrene materials, klass 20, cooling packs; household appliances included in this class; small apparatus, instruments and containers for household or kitchen use (neither of precious metal nor coated therewith); soap holders; toilet paper holders; toothbrush glass holders; clothes racks; mouse traps; flower and plant pots (mainly non metallic); wire candlesticks; watering tools, namely spray nozzles for pipes; rose heads and hoses; bath towel holders; napkin rings; hand towel holders; glass goods, porcelain and earthenware for household and kitchen use; colanders; porcelain figurines; sculptures not included in other classes for fountains; flowerpot holders not of paper; holders for toiletry articles; plant sprays; garden gnomes not included in other classes; watering devices, including watering devices for lawns; buckets; wooden plates; disposable tableware; art objects made of glass, porcelain and earthenware; toothbrushes; toilet brushes and holders therefor; watering devices; mangers and drinking bowls for birds; fiberglass strips and mats not included in other classes; brushes (except paintbrushes); climbing poles, not of metal, for plants; stakes; pails, klass 21, towing cables not of metal for motor vehicles, klass 22, clothing, footwear, headgear; work clothes, klass 25, non-textile wall hangings; carpets and rugs; doormats; mats; linoleum and other floor coverings; oilcloth; toilet mats, wall finishes made of paper, plastic materials, natural fibers or synthetic material; insulating wallpaper; insulating floor coverings, klass 27, agricultural, horticultural and forestry products, namely grains and other reproduction means, raw cereals, unsawn timber, natural seeds, plants and flowers; Christmas trees (cut), nursery plants, fruit-bearing trees; flower arrangements consisting of natural flowers, dried flowers, klass 31, och frame making on order, klass 40.

PRV har som hinder för märkets giltighet i Sverige anfört att innehavarens märke är förväxlingsbart med gemenskapsvarumärket BAUHAUS DESSAU, med registreringsnummer 1373893, som registrerats för flyttbara byggnader (byggnationer) av metall; små smidesvaror av järn och metall; varor av oädla metaller, ingående i klass 6; byggnadsmaterial av metall, klass 6, lampor och lyktor, klass 11, ädla metaller och deras legeringar samt varor av ädla metaller eller överdragna därmed (ingående i klass 14); smycken, ädelstenar; ur och tidmätningsinstrument, klass 14, trycksaker; målningar, litografier; fotografier, affischer, klass 16, flyttbara byggnader (byggnationer), ej av metall; monument; byggnadsmaterial (ej av metall), klass 19, möbler, speglar, tavelramar; varor, ingående i klass 20, av trä, kork, vass, rotting, korg, horn, ben, elfenben, valfiskben, snäckskal, bärnsten, pärlemor, sjöskum eller av ersättningar för dessa material, eller av plast, klass 20, varor av glas, porslin och keramik, ingående i klass 21; apparater och behållare för hushåll och kök, ingående i klass 21, klass 21, textilier och textilvaror (ingående i klass 24); sängkläder och bordsdukar; väggbeklädnader av textil, klass 24, klädesartiklar; huvudbonader; fotbeklädnader, klass 25, mattor och mattbeläggningar, linoleum och andra material för golvbeläggningar; tapeter, ingående i klass 27, klass 27, organisation och anordnande av resor, rundturer och visningar; reseeskort, klass 39, arrangerande och hållande av seminarier; utbildningstjänster; arrangerande och hållande av mässor och utställningar för kulturella ändamål; kulturverksamhet; dia- och filmföredrag och -visningar, klass 41, planering och rådgivning vid byggnads- och konstruktionsarbete; arkitekturverksamhet; inredningsarkitektur; utskänkning av mat och dryck till gäster; bokning av kortvarigt boende, klass 42.



Innehavaren har i huvudsak anfört att märkena inte är förväxlingsbara då de inte är tillräckligt lika och dessutom inte avser skydd för samma varor och tjänster.

SKÄL

Av 5 kap. 8–9 §§ varumärkeslagen framgår att PRV ska besluta att den internationella varumärkesregistreringen helt eller delvis inte ska gälla i Sverige, om hinder föreligger enligt i 2 kap. 4–11 §§.

Enligt 2 kap. 8 § första stycket 2 varumärkeslagen får ett varumärke inte registreras om det är identiskt med eller liknar ett äldre varukännetecken för varor eller tjänster av samma eller liknande slag, om det finns en risk för förväxling inbegripet risken för att användningen av varumärket leder till uppfattningen att det finns ett samband mellan den som använder varumärket och innehavaren av varukännetecknet.

PRV gör följande bedömning.

Beträffande märkeslikheten konstateras att det särskiljande ordet i innehavarens märke är identiskt med det mothållna märkets inledande, särskiljande ord, varför märkeslikhet föreligger. Övriga ord och figurativa inslag i märkena förändrar inte PRVs bedömning då de inte distanserar märkena ifrån varandra i tillräckligt hög grad.

Det föreligger vidare varuslagslikhet mellan varor som föreliggande internationella registrering omfattar i klass 6, 11, 16, 19, 20, 21, 25 och 27 (se ovan) och motsvarande varor i samma klasser som det motanförda varumärket omfattar då de kan köpas på samma försäljningsställe och kan komplettera varandra.

Vid en helhetsbedömning finner PRV därmed att de motstående märkena är förväxlingsbara.

Med hänsyn till de skäl som ovan anförts ska den internationella registreringen delvis inte gälla i Sverige.
