## BESLUT

Patent- och registreringsverket (PRV) upphäver varumärkesregistreringen nr 506012 med stöd av 2 kap. 28 § varumärkeslagen (2010:1877).

## ÄRENDET

Invändningen avser varumärket AAB med registreringsnummer 506012, registrerat för följande varor/tjänster:

Invändaren yrkar att innehavarens registrering ska upphävas och anförs som grund att märket är förväxlingsbart med följande kännetecken:

Firman ABB AB med organisationsnummer 556029-7029, registrerad för följande verksamhet:

För egen del eller annans räkning utveckla, konstruera, tillverka, marknadsföra, försälja, ta i drift samt underhålla produkter, reservdelar, system och anläggningar för överföring och distribution av elektrisk kraft, för automatisering och effektivisering inom olika verksamheter samt erbjuda service och underhållslösningar för ökat anläggningsutnyttjande och tillgänglighet även som andra tjänster i anslutning därtill. Idka annan liknande industrirörelse och handel. Bedriva in- och utlåning från och till närliggande bolag, svenska och utländska. Utfärda garantier för närliggande bolag, svenska och utländska. Bedriva med förestående verksamhetsgrenar sammanhängande rörelse även som att förvärva och förvalta aktier och andelar i andra företag.

Vidare har invändaren anfört att varumärkena är väl ansedda och att användningen av innehavarens märken skulle dra otillbörlig fördel av eller vara till skada för varukännetecknens särskiljningsförmåga eller anseende.

Invändaren anför vidare att innehavarens registrering är förväxlingsbart med de kännetecken som invändaren använde vid tidpunkten för ansökan och att innehavaren har varit i ond tro.

Till stöd för sin invändning anför invändaren i huvudsak följande: Det råder klar märkeslikhet mellan AAB och ABB och förväxlingsrisk föreligger. Båda är trebokstavsmärken som inleds och avslutas med identiska bokstäver. Detta medför både ett visuellt och fonetiskt förväxlingsbart intryck. Det föreligger också identitet och samband mellan samtliga de varor som varumärket AAB avser och de varor och tjänster som omfattas av invändarens kännetecken. Invändaren har härvid hänvisat till Patentbesvärssättens dom i mål nummer 09-222 (SBF).

ABB är en internationell koncern med verksamhet i fler än 100 länder. ABB går tillbaka till slutet av 1800-talet och ABB är idag marknadsledande inom produkter och system för kraftöverföring sam process- och industriautomation. År 1931 registrerades firman ABB AB. Innehavarens registrering drar otillbörlig fördel av ABB:s anseende genom att AAB associeras med ABB. Innehavaren hade kännedom om användningen av ABB-koncernens kännetecken och var därmed i ond tro.

Innehavaren, som beretts tillfälle att yttra sig, har inte bemött invändningen.

## SKÄL

Enligt 2 kap. 8 § första stycket 2 varumärkeslagen får ett varumärke inte registreras om det är identiskt med eller liknar ett äldre varukännetecken för varor eller tjänster av samma eller liknande slag, om det finns en risk för förväxling, inbegripet risken för att användningen av varumärket leder till uppfattningen att det finns ett samband mellan den som använder varumärket och innehavaren av varukännetecknet.

Med ett varukännetecken avses, enligt 2 kap 8 § andra stycket 2 varumärkeslagen, bland annat en nationell varumärkesregistrering och en internationell varumärkesregistrering som fått giltighet i Sverige.

Av 2 kap. 9 § andra punkten varumärkeslagen framgår att de hinder som avses i 2 kap. 8 § första stycket 1-3 ska gälla på motsvarande sätt i fråga om en registrerad firma som används i näringssverksamhet.

Frågan om förväxlingsbarhet ska avgöras vid en helhetsbedömning där samtliga omständigheter av betydelse i sammanhanget ska beaktas, framför allt märkenas likhet samt likheten avseende de varor/tjänster som märkena avser. Om varu- eller tjänsteslagslikhet är för handen ska en bedömning av märkenas visuella, fonetiska och begreppsmässiga/konceptuella likheter göras med utgångspunkt i det helhetsintryck som varumärkena förmedlar med hänsyn till bland annat deras särskiljande och dominanterande delar (EU-domstolens dom i mål C-251/95, "Sabel", punkterna 22 och 23). Hänsyn ska även tas till det faktum att genomsnittskonsumenten sällan har möjlighet att göra en direkt jämförelse mellan varumärkena utan måste förlita sig på en oklar minnesbild av märkenas utföranden. (EU-domstolens dom i mål C-342/97, "Lloyd Schuhfabrik Meyer", punkt 26).

Av 2 kap. 8 § första stycket 3 varumärkeslagen framgår att ett varumärke inte får registreras om det är identiskt med eller liknar ett äldre varukännetecken som är känt inom en betydande del av omsättningsskretsen, och användningen av varumärket skulle dra otillbörlig fördel av eller utan skälig anledning vara till skada för varukännetecknets särskilningsförmåga eller anseende.

Vid bedömningen av om ett varukännetecken är känt inom en betydande del av omsättningsskretsen ska samtliga relevanta omständigheter i ärendet beaktas, särskilt varumärkets marknadsandel, i hur stor omfattning det används, i vilket geografiskt område och hur länge varumärket har används, samt hur stora investeringar företaget har gjort för att marknadsföra varumärket (se EU-domstolens dom i mål C-375/97, "Chevy", punkt 27).

Enligt 2 kap. 8 § första stycket 4 varumärkeslagen får ett varumärke inte registreras om det kan förväxlas med ett kännetecken som användes här i landet eller i utlandet av någon annan vid tidpunkten för ansökan och som fortfarande används, om sökanden var i ond tro vid tidpunkten för ansökan.

*PRV gör följande bedömning*

Invändaren har åberopat ett antal kännetecken bestående av eller innehållandes märkesordet ABB till stöd för sin invändning. Av processekonomiska skäl kommer prövningen inledningsvis begränsas till att avse de av invändarens varumärken som ligger närmast innehavarens registrering, nämligen registrering nr 781685.

*Välkänt?*

Invändaren har gjort gällande att dennes varumärke ABB är väl välkänt och att det därmed förvärvat ett utökat skyddsomfång. Vidare har anfört att användningen av varumärket skulle dra otillbörlig fördel av eller vara till skada för varukännetecknets särskiljningsförmåga eller anseende.

PRV konstaterar att det invändaren anfört och den bevisning som åberopats, vilken enbart består av utdrag från varumärkesregister och bolagsverket inte kan ligga till grund för slutsatsen att varumärket ABB är känt inom en betydande del av omsättningsskretsen för några av de aktuella varorna eller tjänsterna. Innehavarens registrering kan därmed inte upphävas på den grunden att användningen av varumärket skulle dra otillbörlig fördel av eller vara till skada för det äldre märkets särskiljningsförmåga eller anseende.

Emellertid får det invändaren anfört anses visa att varumärket ABB har varit i bruk under en längre tidsperiod med en viss styrka vad gäller exponering och geografisk spridning. Mot denna bakgrund finner PRV att varumärket ABB åtnjuter en förstärkt känneteckenskraft i förhållande till de varor i klass 9 som är aktuella för bedömningen i detta fall. Detta är en omständighet som ska beaktas vid förväxlingsbedömningen.

*Ond tro?*

Bestämmelsen i 2 kap. 8 § första stycket 4 varumärkeslagen ger ett skydd för den som använder ett kännetecken mot att någon annan, i ond tro, får registrera ett varumärke som kan förväxlas med detta kännetecken. Det fordras att det åberopade kännetecknet användes vid tidpunkten för varumärkesansökan och att det alltjämt används. Bedömningen av om den som gett in varumärkesansökan varit i ond tro ska göras vid tidpunkten för ansökan (angående ond tro, se EU-domstolens avgörande i mål C-529/07, "Chocoladefabriken Lindt & Sprüngli AG". En förutsättning för att det åberopade kännetecknet ska kunna utgöra hinder mot innehavarens registrering är att kännetecknet, när registreringsansökan gavs in, användes för att marknadsföra varor eller tjänster av samma eller liknande slag som de som registreringen avser. Det åligger invändaren att visa att sådan användning har skett.

Invändaren har till utredningen inte tillfört något material eller angett några uppgifter som stöder dennes anförda talan om ond tro. PRV finner heller inget annat i utredningen som kan läggas till grund för sådan slutsats. Vid dessa förhållanden kan innehavarens varumärke inte upphävas med stöd av 2 kap. 8 § första stycket 4 varumärkeslagen.

*Förväxling?*

PRV gör följande bedömning vad gäller frågan om förväxling.

De batterivaror som innehavarens märke avser i klass 9 faller inom den bredare kategorin av batterier som invändarens märke avser i samma klass. Därmed föreligger varuslagsidentitet.

Innehavarens märke avser vidare centralenheter för datorer (processorer); databärare för datorer med registrerad programvara; elektroniska komponenter för datorer; kylkropp som används för datorer; kylelement för datorer; komponenter för datorer; moderkort för datorer samt dotterkort för datorer; kretsar för datorer; kretskort för användning med datorer; interna kylfläktar för datorer; tangentbord för användning med datorer; röstgränssnitt (för datorer); skivenheter för användning med datorer; parallellportar för datorer. Dessa varor faller inom den bredare kategorin av varor som invändarens kännetecken avser, nämligen dataprocessutrustning och datorer. Därmed föreligger varuslagsidentitet.

Bedömningen av märkenas förväxlingsbarhet, inbegripet deras visuella, fonetiska och begreppsmässiga likheter, ska ske med utgångspunkt i uppfattningen hos genomsnittskonsumenten av den kategorin av varor eller tjänster som avses. I förevarande fall riktar sig de varor där identitet och likhet har konstaterats till konsumenter i allmänhet.

De motstående märkena består av bokstäverna AAB respektive ABB. Då båda märkena består av trebokstavskombinationer som är uppbyggda av A och B föreligger såväl visuell som fonetisk likhet. Begreppsmässigt är både märkena fantasior och torde inte ge omsättningskretsen några specifika associationer.

Bokstavbeteckningar har visserligen i regel ett begränsat skyddsomgång. Med beaktande av den förstärka känneteckenskraften som invändarens märke förvärvat samt med beaktande av den konstaterade varuslagidentiteten och märkeslikheten märkena emellan, finner PRV vid en helhetsbedömning att märkena är förväxlingsbara.




